


MEMORANDUM OF UNDERSTANDING ("MOU")
BETWEEN
SATKYNBAY TENTISHEV MEMORIAL ASIAN MEDICAL INSTITUTE
AND
COLLEGE OF ALLIED HEALTH SCIENCES

THIS MEMORANDUM OF UNDERSTANDING ("MOU") is made by and between the Satkynbay Tentishev Memorial Asian Medical Institute, Kant C. Gagarina Str. 58, Kyrgyz Republic (hereinafter referred to as "AsMI" or "First Party"), represented by the Rector Prof. Dr. Selpiev Toychubek Tulekovich, acting on the basis of the Charter of AsMI, and College of Allied Health Sciences 38 & 39 West Wood Colony, Lahore, Islamic Republic of Pakistan (hereinafter referred to as "CAHS" or "Second Party") represented by the Principal Dr. Fuad Hameed Rai, acting on behalf of the of College of Allied Health Sciences. Both AsMI / First Party and CAHS / Second Party shall also be collectively referred to as the "Parties".

WHEREBY, the following is agreed between the two parties.

- i. That the First Party "AsMI" requires space for teaching and capacity building of its students from Second Party "College of Allied Health Sciences 38/39 West Wood Colony, Lahore" and the Second Party agrees to provide space for the above mentioned purpose without affecting its own operations.
- ii. That the First Party will pay the Second Party for the infrastructure and resources which the second Party will provide.
- iii. That this Memorandum of Understanding does not create any relationship between the First & the Second Party except for provision of space or educational resources to First Party.
- iv. That Second Party has nothing to do with the fee collection and conduction of classes and all such responsibilities will be that of the First Party.
- v. That the Second Party has developed a state of the art infrastructure which it is providing to the First Party and any breakage or damage to the property or infrastructure will create a liability to be paid for by the First Party.
- vi. That this MOU in no way creates any relationship between the two parties (I.e., First Party and Second Party) or gives any rights to the First Party (which it may claim later) except for the purpose that is mentioned above.
- vii. That further details will be incorporated in a document drafted later after this MOU comes into force.

This Memorandum is signed in two copies in English. Each of the parties will keep one copy of this Memorandum. In the event of a change in


