

**MEMORANDUM OF UNDERSTANDING (“MOU”)  
BETWEEN  
SATKYNBAY TENTISHEV MEMORIAL ASIAN MEDICAL INSTITUTE  
AND  
AKHTAR SAEED MEDICAL & DENTAL COLLEGE**

THIS MEMORANDUM OF UNDERSTANDING (“MOU”) is made by and between the Satkynbay Tentishev Memorial Asian Medical Institute, Kant C. Gagarina Str. 58, Kyrgyz Republic (hereinafter referred to as “AsMI”), represented by the Rector Prof. Dr. Selpiev Toychubek Tulekovich, acting on the basis of the Charter of AsMI, and Akhtar Saeed Medical & Dental College, 80- Boulevard, Tulip Block Sector “C”, Bahria Town, Lahore, Islamic Republic of Pakistan (hereinafter referred to as “AMDC”) represented by the Chairman Dr. Farooq Saeed Khan, acting on the basis of the Charter of AMDC. Both AsMI and AMDC shall also be collectively referred to as the “Parties”.

**P R E A M B L E**

This MOU is only for exchange of teaching faculty to attend Seminars and Conferences.

**ARTICLE I**

**AREAS OF COOPERATION**

In order to carry out and fulfil the aims of this MOU, AsMI and AMDC will appoint an appropriate person at each of their campuses to coordinate the development and conduct of joint activities. Through these contact persons, either party may initiate proposals for activities under this MOU. Specific details of any activity will be set forth in a Letter of Agreement, which, upon signing by appropriate authorities at both sides (Parties), and approval, will become an integral part of this MOU.

**ARTICLE II**

**ENTRY INTO EFFECT AND DURATION**

Upon approval by each institution, this MOU shall remain in effect for a period of two (2) years unless terminated earlier by either institution (party). Such termination by one institution shall be effected by giving the other party (institution) at least thirty (30) days advance written notice of its intention to terminate. Termination shall be without penalty. If this MOU is terminated, neither AMDC nor AsMI shall be liable to the other for any monetary or other losses which may result. This MOU will be terminated if it is against the law, rules & regulations of Pakistan Medical Commission and Higher Education Commission of Pakistan.

**ARTICLE III**

**EXCHANGE AND VISIT OF FACULTY MEMBERS**

The faculty members of the AMDC will participate in conferences and seminars organized by AsMI in Kyrgyz, funded by the AsMI. The AsMI shall bound to bear all expenses of the AMDC’s Faculty Members including travelling, accommodation, boarding, refreshment, foods and all such like other expenses.

#### ARTICLE IV

The parties will use the information and documents obtained under this Memorandum only for the implementation of this Memorandum and will not disclose this information to a third party without the written consent of the Party that provided this information. This provision will continue to apply after the termination of this Memorandum.

#### ARTICLE V

Both the parties can terminate the Memorandum of understanding without signing any agreement. This MOU will automatically revoked, if the AMDC faculty is not invited within ninety (90) days of signing this MOU.

#### ARTICLE VI

This Memorandum is signed in two copies in English. Each of parties will keep one copy of this Memorandum. In the event of a change in addresses, details and other data, the Parties undertake to immediately notify each other by submitting official notifications.
